1. WHO WE ARE

This website is operated by **Hudson Outsourcing LLC**, which operates under the brand **Together: The Hudson Collective**.

Hudson Outsourcing LLC is responsible for the collection, use and protection of personal information described in this Privacy Policy.

2. INFORMATION WE COLLECT

We may collect personal information when you:

- complete a contact form

Information collected may include:

- Name
- Email address

- Information contained in messages or enquiries

We may also automatically collect technical information such as:

- IP address
- browser type
- device type
- pages visited



3. HOW WE USE YOUR INFORMATION

We use personal information to:

- respond to enquiries
- provide information about our services

- improve our website and services
- analyze website usage

4. MARKETING COMMUNICATIONS

If you opt in to receive communications, we may send:

5. HOW WE PROCESS INFORMATION

We process personal information for the purposes described in this Privacy Policy, including:

- sending marketing communications where permitted by law
- operating, maintaining and improving our website and services
- protecting our legal rights and complying with legal obligations

6. DATA SHARING

We may share data with trusted service providers including:

- website hosting providers
- analytics providers
- CRM systems
- email marketing platforms

These providers only process data under our instructions and must keep it secure.

We do not sell personal information.



7. DATA RETENTION

Personal information is retained only for as long as necessary to fulfil the purposes it was collected for and to comply with legal obligations.

8. INTERNATIONAL TRANSFERS

We may transfer, store and process personal information in countries outside your state or country of residence, including where our service providers operate internationally.

Where we do so, we take reasonable steps to ensure personal information remains appropriately protected and is handled in accordance with applicable privacy laws.

9. CHILDREN'S PRIVACY

This website is not directed to children under the age of 13. We do not knowingly collect personal information from children under 13. If we become aware that personal information has been collected from a child under 13, we will take reasonable steps to delete it.
